Davide is fluent in Italian, English, German and French, with basic knowledge of Arabic.

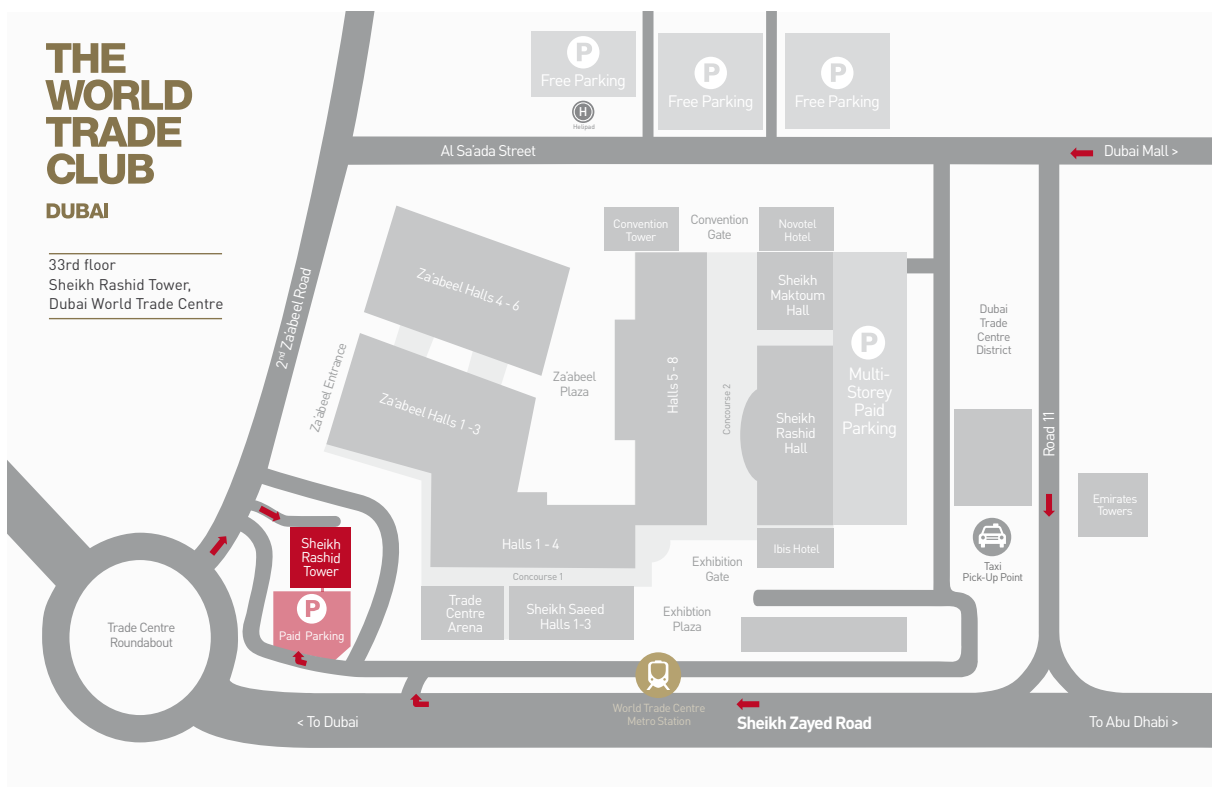


### Alexandros Nousias, Compliance Consultant

\*GDPR is a regulation in EU law on data protection and privacy for all individuals within the European Union. It addresses the export of personal data outside the EU. It will become enforceable starting on 25 May 2018, and will be applicable to any organization or company outside of the EU that sells products/services to EU citizens, and collects information about them.
